Despite our relentless efforts to resolve the matter, we regret to inform you that Vapi Nagar Palika has coerced us into halting all business operations within the premises of the lake property. This instruction was conveyed verbally, without any formal written intimation or justification provided by Vapi Nagar Palika. Despite our numerous attempts to seek clarification and express our concerns through written communication, we have received no response or acknowledgment from Vapi Nagar Palika to date.

Furthermore, we wish to emphasize that we have dispatched several written communications to Vapi Nagar Palika seeking clearance of pending issues and clarification on the matter. Regrettably, no response has been received from Vapi Nagar Palika, leaving us in a state of uncertainty and legal limbo.
