With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Assistant Commissioner CGST & CX., Park Street Division, Kolkata South Commissionerate for the period April 2018 to March 2019 imposing demand of INR 1,92,32,646/- (Tax INR 91,36,649/-, interest INR 91,82,332/- and penalty of INR 9,13,665/-) under Goods and Service Tax Act,2017.

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellant authorities.
