Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/ Madam,

In Continuation to our earlier letter dated June 09, 2014 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with Para A of Part A of Schedule III to the said Regulations, we wish to inform you that Hon'ble Court of Madhya Pradesh has passed Decree in favour of DAAWAT Foods Limited (Material Subsidiary of LT Foods Limited) (hereinafter referred to as "the Company") in Commercial Suit related to Fire incident that took place on June 07, 2014 at plant location of the Company situated at Mandideep, Madhya Pradesh.

Total loss amount claimed by the Company from the Insurance Company i.e. Oriental Insurance Company limited, New Delhi was Rs. 189.72 crores. Post filing of claim Insurance Company appointed multiple surveyor's and the Insurance Company based on the report submitted by the last surveyor repudiated the claim.

Company has thereafter filed a Commercial Suite with the Hon'ble Court of Madhya Pradesh against the Oriental Insurance Company Limited on June 26, 2016. The Hon'ble Court of Madhya Pradesh, on December 22, 2023 passed the Order in favour of the Company, certified copy of the Order is still awaited.

Court has allowed the claim of the Company amounting to Rs. 161.20 crores as per terms and condition of the Insurance policy alongwith interest thereon @6% p.a. w.e.f. the date of loss.
