- 3.1.2 The Acquirers had entered into a Share Purchase Agreement ("SPA") with Sellers on Wednesday, November 01, 2023 as per which the Acquirers agreed to acquire 8,99,950 equity shares of Rs. 10/each, representing 75.00% of the Voting Share Capital of Target Company at a price of Rs. 17.00/(Rupees Seventeen Only) per equity share of Rs. 10/each (Negotiated Price) for a total consideration of 1,52,99,150/- (Rupees One Crore Fifty Two Lakh Ninety Nine Thousand One Hundred and Fifty Only), payable in cash, subject to the terms and conditions as contained in the SPA. The Sellers are part of the Promoters/ Promoter Group of the Target Company and also are in management control of Target Company. The details of Sellers are as under:

- 3.1.3 The Acquirers holds 8,99,950 Equity Shares of the Target Company (representing 75.00% of the paid up and voting equity capital of the Target Company) pursuant to the consummation of Underlying Transaction under the SPA on January 05, 2024 at a price of Rs. 17/- per Equity Share in compliance with Regulation 22(2) of SEBI (SAST) Regulations.
- 3.1.4 A summary of the salient features of the SPA, which are all subject to detailed terms in the SPA, include the following:
 - (i) The Acquirers will acquire the entire sale shares i.e., 8,99,950 equity shares from the Sellers at Rs.17.00/- per share amounting to total consideration of Rs. 1,52,99,150 (Rupees One Crore Fifty Two Lakhs Ninety Nine Thousand One Hundred and Fifty).

- a. Upfront Rs. 3.40 per share amounting to total consideration of INR 30,59,830 (Rupees Thirty Lakhs Fifty Nine Thousand Eight Hundred and Thirty only) at the time of execution of this Agreement as Earnest Money Deposit.
- b. The Balance amount of Rs. 1,22,39,320 (Rupees One Crore Twenty Two Lakhs Thirty Nine Thousand Three Hundred and Twenty Only) on closing date.
- (ii) The Closing shall be achieved within such period as specified in Regulation 22(3) of SAST Regulations. The Closing Date may be extended by SEBI in accordance with the proviso to Regulation 22(3) of SAST Regulations ("Closing Date").

However, in compliance with Regulation 22(2) of SAST Regulations and other relevant provisions of the SAST Regulations, the Purchasers may after the expiry of twenty-one (21) working days from the date of detailed public statement, act upon the transaction contemplated under this Agreement.

- (iii) The SPA may be terminated upon the occurrence of any of the following events each of which events are outside the reasonable control of the Acquirers as detailed in SPA.
 - a. If the Acquirers and/or Sellers fail to comply with the provisions of the SEBI (SAST) Regulations, the SPA may be terminated before the closing and shall not be acted upon; or

Accordingly, the Acquirers had acquired 8,99,950 Equity Shares of the Target Company (representing 75.00% of the paid up and voting equity capital of the Target Company) pursuant to the consummation of Underlying Transaction under the SPA on January 05, 2024 at a price of Rs. 17/- per Equity Share in compliance with Regulation 22(2) of SEBI (SAST) Regulations.
- 3.1.8 In compliance with Regulation 24(1) read with Regulation 17, as more than entire consideration is deposited in the Escrow Account, the Acquirers may reconstitute the Board of Directors of the Target Company by appointing themselves or person(s) representing them on the Board of Directors of the Target Company. Accordingly, Mr. Ganesh Ramesh Nibe and Mr. Venkateswara Gowtama Mannava

- were appointed on the Board of the Target Company on January 12, 2024 in compliance with the proviso to Regulation 24(1) of SEBI (SAST) Regulations and they are representing the acquirers on the Board of Target Company.
- 3.1.9 This Offer is not pursuant to any open market purchase or a global acquisition resulting in indirect acquisition of the Equity Shares of the Target Company.
- 3.1.10 The Proposed change in control of the Target Company is not through any Scheme of Arrangement.
- 3.1.11 No formal agreement has been made between Acquirers with regard to acquisition of the Equity Shares pursuant to this Open Offer.

- 3.2.2 Acquirers are making this Open Offer in terms of Regulations 3(1) and 4 of SEBI (SAST) Regulations to acquire upto 3,00,050 (Three Lakh and Fifty) equity shares of Rs. 10/- each representing 25.00%, being the remaining Public Shareholding of the Company, of the Voting Share Capital at a price of Rs. 17.00/- each (Rupees Seventeen Only) aggregating to a total consideration of Rs. 51,00,850/- (Rupees Fifty One Lakh Eight Hundred and Fifty Only) (assuming full acceptance), payable in cash, in accordance with Regulation 9(1)(a) of the SEBI (SAST) Regulations and subject to terms and conditions set out in the PA, the DPS and this LOO.
- 3.2.3 The Equity shares of the Target Company which are to be acquired by the Acquirers should be free from liens, charges and encumbrances together with all rights attached thereto, including the right to all dividends, bonus and rights offer declared hereafter.

- 3.2.4 This offer is not subject to receipt of any statutory approvals. However, it will be subject to all statutory approvals that may become applicable at a later date as mentioned in paragraph 7.4 of this Letter of Offer.

- 6.1.7 There have been no corporate actions by the Target Company warranting adjustment of any of the relevant price parameters under Regualtion 8(9) of the SEBI (SAST) Regulations.
- 6.1.8 The Acquirers shall disclose during the offer period, every acquisition made by them of any equity shares of the Target Company, to the Stock Exchange and to the Target Company at its registered office within twenty-four hours of such acquisition in accordance with Regulation 18(6).
- 6.1.9 In case the Acquirers acquires or agrees to acquire any shares or voting rights in the Target Company during the offer period, whether by subscription or purchase, at a price higher than the Offer price, the offer price shall stand revised to the highest price paid or payable for any such acquisition in terms of Regulation 8(8) of SEBI (SAST) Regulations. - 6.2.7 In case of any upward revision in the Offer Price and/or the Offer Size, the Acquirers shall deposit additional appropriate amount into an Escrow Account prior to effecting such revision, in terms of Regulation 18(5) of the SEBI (SAST) Regulations.
- 6.2.8 Based on the above, the Manager to the Offer is satisfied about the ability of the Acquirers to implement the Offer in accordance with the SEBI (SAST) Regulations and that firm financial arrangements for fund and money for payment through verifiable means are in place to fulfil the obligations of the Acquirers under the Offer.

7. TERMS AND CONDITIONS OF THE OFFER

Persons who have acquired Equity Shares (irrespective of the date of purchase) but whose names do not appear on the register of members of the Target Company on the Identified Date are also eligible to participate in the Offer.
- 7.1.3 This Offer is not conditional upon any minimum level of acceptance in terms of Regulation 19(1) of SEBI (SAST) Regulations and is not a competing offer in terms of the Regulation 20 of SEBI (SAST) Regulations.
- 7.1.4 The Letter of Offer specifying the detailed terms and conditions of the Offer along with the Form of Acceptance-cum-Acknowledgement shall be sent through electronic means to those Public Shareholder(s) who have registered their email ids with the depositories and also will be dispatched through physical mode by registered post / speed post / courier to those Public Shareholder(s) who have not registered their email ids and to those Public Shareholder(s) who hold Equity Shares in physical form. Further, on receipt of request from any Public Shareholder to receive a copy of Letter of Offer in physical form, the same shall be provided. In case of non-receipt of LOO and the Acceptance Form, please follow the procedure mentioned in paragraph 8.17.
- 7.1.5 Non-receipt or delayed receipt of the Letter of Offer by any person, or accidental omission to dispatch this Letter of Offer to any shareholder, shall not invalidate the Offer in any way. The last date by which the Letter of Offer would be dispatched to each of the Public Shareholders is Thursday, January 25, 2024. In terms of Regulation 18(2) the letter of offer shall be dispatched to the shareholders whose names appear on the register of members of the Target Company as of the identified date. Every person holding shares, regardless of whether he held shares on the identified date or has not received the letter of offer, shall be entitled to tender such shares in acceptance of the open offer.
- 7.1.6 The Public Shareholders who tender their Equity Shares under the Offer shall ensure that the Equity Shares are free and clear from all liens, charges and encumbrances and shall ensure that such Equity Shares when acquired by the Acquirers will be acquired free and clear from all liens, charges and encumbrances and together with all rights attached thereto, including but not limited to the rights to all dividends, bonus and rights declared thereafter.
- 7.1.7 Public Shareholders to whom the Offer is being made are free to offer their shareholding in the Target Company in whole or in part while accepting the Offer. The acceptance must be unconditional and should be absolute and unqualified. In the event any change or modification is made to the Form of Acceptance-cum-Acknowledgement or if any condition is inserted therein by an Public Shareholder, the

Manager to the Offer and the Acquirers reserve the right to reject the acceptance of this Offer from such Public Shareholder.

- 8.4 The facility for acquisition of shares through stock exchange mechanism pursuant to the Offer shall be available on the BSE in the form of a separate window (Acquisition Window).
- 8.5 The Acquirers have appointed Sushil Financial Services Private Limited ("**Buying Broker**") for the Open Offer through whom the purchases and settlement of Open Offer shall be made during the Tendering Period.

- All the Public Shareholders who desire to tender their Equity Shares under the Offer should consult with their depository participants and their respective stock brokers ("Selling Broker(s)") well in advance to understand the process and methodology in relation to tendering of the Equity Shares through the Stock Exchange during the Tendering Period.
- 8.7 During the Tendering Period, the tender of the Equity Shares by the Public Shareholders in this Offer will be placed through their respective Selling Brokers during normal trading hours of the secondary market.
- 8.8 Separate Acquisition window will be provided by BSE to facilitate placing of sell orders. The Selling Brokers can enter orders for demat Equity Shares as well as physical Equity Shares.

- 8.14 The Equity Shares and all other relevant documents should be sent to the Registrar to the Offer and not to the Acquirers or to ACL or to the Manager to the Offer.
- 8.15 The Public Shareholders holding Equity Shares in physical mode will be required to fill the respective Form of Acceptance-cum-Acknowledgement. Detailed procedure for tendering Equity Shares has been included in the Form of Acceptance-cum-Acknowledgement.
- 8.16 Modification / cancellation of orders will not be allowed during the period the Offer is open.

8.17 Procedure for tendering the shares in case of non-receipt of Letter of Offer

Persons who have acquired Equity Shares but whose names do not appear in the register of members of the Target Company on the Identified Date, or unregistered owners or those who have acquired Equity Shares after the Identified Date, or those who have not received the Letter of Offer, may also participate in this Offer. A Shareholder may participate in the Offer by approaching their broker and tender Equity Shares in the Open Offer as per the procedure mentioned in this Letter of Offer or in the Form of Acceptance—cum-Acknowledgement. The Letter of Offer along with Form of Acceptance-cum-Acknowledgement will be dispatched to all the Public Shareholders of the Target Company as of the Identified Date.

In case of non-receipt of the Letter of Offer, such Public Shareholders of the Target Company may download the same from the SEBI website (www.sebi.gov.in) or BSE website (www.bseindia.com) or obtain a copy of the same from the Registrar to the Offer on providing suitable documentary evidence of holding of the Equity Shares of the Target Company. Alternatively, in case of non-receipt of the Letter of Offer, shareholders holding shares may participate in the Offer by providing their application in plain paper in writing signed by all shareholder, stating name, address, number of shares held, client ID number, DP name, DP ID number, number of shares tendered and other relevant documents such as physical share certificate and Form SH-4 in

case of shares being held in physical form. Such shareholders have to ensure that their order is entered in the electronic platform to be made available by BSE before the closure of the Offer. It may be noted that no indemnity is required from the unregistered shareholders.

- 8.18 Non-receipt of this Letter of Offer by, or accidental omission to dispatch this Letter of Offer to any shareholder, shall not invalidate the Offer in any way.
- 8.19 The acceptance of the Offer made by the Acquirers is entirely at the discretion of the Shareholders of the Target Company. The Acquirers does not accept any responsibility for the decision of any Shareholder to either participate or to not participate in the Offer. The Acquirers will not be responsible in any manner for any loss of share certificate(s) and other documents during transit and the Shareholders are advised to adequately safeguard their interest in this regard.

8.20 Acceptance of Equity Shares

Registrar to the Offer shall provide details of order acceptance to Clearing Corporation within specified timelines. In the event that the number of Equity Shares (including demat Equity Shares, physical Equity Shares and locked-in Equity Shares) validly tendered by the Shareholders under this Offer is more than the number of Offer Shares, the Acquirers shall accept those Equity Shares validly tendered by the Shareholders on a proportionate basis in consultation with the Manager, taking care to ensure that the basis of acceptance is decided in a fair and equitable manner and does not result in non-marketable lots, provided that acquisition of Equity Shares from a Shareholder shall not be less than the minimum marketable lot. 8.21 Settlement Process

9.1 Unless specifically exempted, capital gains arising from the sale of equity shares in an Indian company are generally **taxable** in India. Any gain realized on the sale of listed equity shares on a stock exchange held for more than 12 (twelve) months, which are sold will be subject to long term capital gains tax and securities transaction tax ("STT").
