EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013 ("the Act")

Regarding Item No 1:

The Board of Directors of the Company had appointed Ms. Leena S Pirgal (DIN 10042575), based on the recommendations of the Nomination and Remuneration Committee, as an Additional Director of the Company, for a period of 1 (One) year with effect from February 13, 2024. Subject to the approval of the Members, Ms. Leena S Pirgal was appointed as a Woman Independent Director for a period commencing from February 13, 2024, upto February 12, 2025, not liable to retire by rotation. In terms of Section 161(1) of the Act, Ms. Leena S Pirgal, being an Additional Director, holds office subject to the approval of shareholders under Section 161(1) of the Companies Act, 2013 ('the Act') and applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations') and is eligible for appointment as an Independent Director.

The Company has received a declaration from her to the effect that she meets the criteria of independence as provided in Section 149(6) and all applicable provisions of the Act and Rules framed thereunder and Regulation 16(1)(b) and all applicable provisions of the SEBI Listing Regulations. In terms of Regulation 25(8) of SEBI Listing Regulations, she has confirmed that she is not aware of any circumstance or situation which exists or may be reasonably anticipated that could impair or impact her ability to discharge her duties. In the opinion of the Board, she fulfills the conditions specified in the Act and SEBI Listing Regulations for appointment as a Woman Independent Director and is independent of the management of the Company.

The Board, based on the recommendation of Nomination and Remuneration Committee, considers that given her skills, integrity, expertise and experience, the association of Ms. Leena S Pirgal would be beneficial to the Company and it is desirable to avail his services as a Woman Independent Director.

Further details as required under SEBI Listing Regulations and Secretarial Standard-2 for General Meetings are provided in Annexure to this Notice.
