'आप' नेताओं पर दर्ज कराए मामले



मनोज तिवारी की गिरफ्तारी हो : 'आप'

जनसत्ता संवाददाता
नई दिल्ली, 5 नवंबर।

सिग्नचर ब्रिज उद्घाटन समारोह में हुए हंगामे को लेकर आम आदमी पार्टी (आप) ने भाजपा को घेरा है। 'आप' का आरोप है कि हंगामे की वजह से दंगे जैसी स्थिति भी बन गई थी जिससे मुख्यमंत्री की सुरक्षा खतरों में पड़ गई। इसलिए 'आप' ने भाजपा प्रदेश अध्यक्ष मनोज तिवारी को गिरफ्तार करने की मांग की है।

पूर्वी दिल्ली लोकसभा सीट की 'आप' की प्रभारी आतिशी मार्लेना ने कहा कि मनोज तिवारी दंगे की स्थिति पैदा करने के लिए समारोह स्थल पर गए थे। पुलिस इस मामले में प्रत्यक्ष या परोक्ष

रूप से शामिल थी। घटना स्थल पर मुख्यमंत्री और अन्य मंत्री उपस्थित थे और हंगामे की वजह से उनकी सुरक्षा के लिए खतरा पैदा हो गया था। 'आप' नेता दिलीप पांडेय ने कहा कि रविवार की घटना में घायल हुए पार्टी के एक कार्यकर्ता ने पुलिस में शिकायत दी है। उन्होंने कहा कि भाजपा के कार्यकर्ताओं को समारोह स्थल से दूर रख पाने में दिल्ली पुलिस की नाकामी के मद्देनजर दिल्ली सरकार कानूनी विकल्पों पर भी विचार कर रही है।

उन्होंने कहा कि इस मामले में केंद्रीय मंत्री राजनाथ सिंह को तिवारी की गिरफ्तारी का आदेश देकर भाजपा और दिल्ली पुलिस की छवि को बचाना चाहिए।

आवास पर विरोध प्रदर्शन करेगी। तिवारी ने बताया कि मंच के पास 'आप' नेताओं और कार्यकर्ताओं से बचाने के लिए पुलिस ने सुरक्षा घेरा बनाकर उन्हें बचाया है। उन पर पुलिस से मारपीट किए जाने के आरोप सरासर गलत हैं। उन्होंने बताया कि हाथापाई की घटना को लेकर भाजपा गंभीर है और इस मामले में उस्मानपुर और नेबसराय थाने में 'आप' नेताओं के खिलाफ शिकायत दर्ज करा दी है।

शीला दीक्षित के खिलाफ आपराधिक मानहानि के मामले से केजरीवाल बरी

दिल्ली की एक अदालत ने कांग्रेस नेता शीला दीक्षित के पूर्व सहायक द्वारा दायर आपराधिक मानहानि के मामले में मुख्यमंत्री अरविंद केजरीवाल को सोमवार को बरी कर दिया।

अतिरिक्त मुख्य मेट्रोपोलिटन मजिस्ट्रेट समर विशाल ने सूबतों के अभाव का हवाला देते हुए आप नेता को राहत दे दी। दीक्षित के पूर्व राजनीतिक सचिव रहे पवन खेड़ा ने अक्टूबर 2012 में बिजली टैरिफ में बढ़ोतरी के खिलाफ प्रदर्शनों के दौरान दीक्षित के खिलाफ कथित टिप्पणी को लेकर आप प्रमुख पर आपराधिक मानहानि का मुकदमा दायर किया था। दीक्षित उस समय दिल्ली की मुख्यमंत्री थीं।
