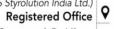

- (2) We have been informed that in terms of the MCA Circulars, the Company **dispatched notice** of postal ballot along with the Explanatory Statement instructions and manner of e-voting process on 12<sup>th</sup> March, 2024 through **electronic mode only** to all the members whose email IDs were registered with the Company / Depositories as on 8<sup>th</sup> March, 2024 ('Cut-off date').
  - Moreover, the Postal Ballot was also conducted only through the remote e-voting process in terms of MCA Circulars.
- (3) The management of the Company is responsible to ensure the compliance with the requirements of Clause 44 of LODR read with the Act and the rules framed thereunder for providing e-voting facility to its shareholders in respect of the aforesaid resolutions. My responsibility as a Scrutinizer for conducting e-voting process is restricted to report on the votes cast 'in favour' or 'against' the aforesaid resolution based on the report generated from the e-voting system provided by NSDL, the authorized agency to provide e-voting facilities engaged by the Company.
- (4) The notice of dispatch was published in two newspapers i.e. Business Standard, Ahmedabad edition in English language and Vadodara Samachar, Vadodara edition in Gujarati language on 14th March, 2024.
- (5) The remote e-voting facility remained open from Friday, 15<sup>th</sup> March, 2024 (9.00 a.m.) to Saturday, 13<sup>th</sup> April, 2024 (5.00 p.m.)
- (6) The members of the Company as on the cut-off date i.e. 8<sup>th</sup> March, 2024 were entitled to vote on the aforesaid resolutions.
- (7) The votes cast were then unblocked on 15<sup>th</sup> April, 2024 at 3:25 p.m. in presence of two witnesses viz. Ms. Ashish Chaudhary and Ms. Bhavisha Dubber who are not in the employment of the Company and who have signed at the end of the report in token of the same.
