Review Report to Board of Directors BRAND REALTY SERVICES LIMITED

We have reviewed the unaudited financial results of BRAND REALTY SERVICES LIMITED (the "Company") for the third quarter and nine months period ended 31st December, 2018, which are included in the accompanying 'Statement of Standalone Unaudited Financial Results for the period ended December 2018' (the "Statement").
