We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. We did not review the interim financial information of Associate JPT Shares Services Private Limited included in the statement, whose financial results are included in the Group and are accounted on equity method. The Consolidated unaudited Financial Results includes the Group's share of profit/(loss) after tax of Rs. (0.05) Lakhs for the quarter ended December 31,2023 and Rs. (0.25) Lakhs for the Nine Months ended December 31,2023 as considered in the statement in respect of associate based on their Interim Financial Information which have not been reviewed by us. In our opinion and according to the information and explanations given to us by the Management, the financial results of the Associate are *not material* to the Group.

Our conclusion on the statement is not modified in respect of our reliance on the interim financial information certified by the management.
