NEW DELHI: In a bid to promote the retirement of old vehicles, the Delhi government plans to provide a subsidy of up to Rs 50,000 in road tax for new to Rs 50,000 in road tax for new cars with better emission stan-dards. Transport department offi-cials have crafted a draft policy on scrapping vehicles, which is expected to be shared with the public soon for their input. The proposed policy is currently under review by the finance under review by the finance department for approval, consid-ering it involves the use of public funds as a subsidy, as reported by. A senior government official highlighted the issue of numer-ous vehicles past their lifespan ous whicles past their lifespan still operating on city roads, con-tributing to pollution. While the transport department had pre-viously impounded such vehi-cles for scrapping, the effort was halted due to Delhi High Court intervention. Following the court's guidance, the government has formulated a draft policy on whicle scrapping, with notestile has formulated a draft policy on vehicle scrapping, with potential varying discounts for commer-cial and private vehicles. "People who will be in possession of bona fide e-invitation cards or e-tickets for attending the Republic Day ceremony will be issued coupons on production of govern production of govern-ment-issued identity cards at stations, which cards at stations, which will be valid for exits from Central Secretariat and Udyog Bhawan stations only to reach Kartavya Path," a Delhi Metro Rail Corporation (DMRC) statement said.The same coupon will be valid for return

NEW DELHI : In a first, Delhi Police identified a dead body and solved a murder case using Ar-tificial Intelligence (AI), an official said on Wednesofficial said on Wednes-day.According to police, the body of an unidenti-fied man was found under Geeta Colony flyover on December 10."The au-topsy of the deceased re-vealed that he had been vealed that he had been strangulated, however, there were no marks on his body," said an official. A 30-member team was formed and Delhi Police employed Al technology to solve the case as the man's face was beyond man's face was beyond recognition because of mans race was beyond recognition because of decomposition. As per officials, using AI, they digitally reconstructed the victim's face and created about 450 posters which were then distributed strategically in the national Capital and shared digitally via WhatsApp groups till January 12.
