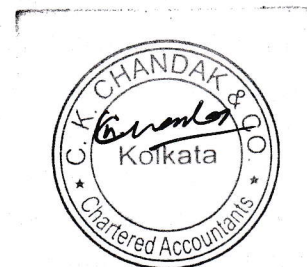

Review Report to the Board of Directors of Ashirwad Steels & Industries Limited
