- 3. Notices and the accompanying documents, have been sent on 27th October, 2023, through electronic mode to those Unsecured Creditors whose e-mail addresses are available with the Company and through courier to those Unsecured Creditors whose e-mail addresses are not available with the Company.
- 4. Notices were also published in English Daily, Business Standard on 28th October, 2023 and in Gujarati Daily, Financial Express, on 28th October, 2023, informing the Unsecured Creditors about convening the Meeting of the Unsecured Creditors for approving the Scheme.
- 5. The Compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to voting to the Unsecured Creditors on the Resolution proposed in the Notice calling the Meeting of the Company was the responsibility of the Management. - The identity of the Unsecured Creditors present whether in Person or through Proxy were verified before the commencement of the Meeting. 114 valid Proxy Forms were received by the Company before the prescribed time.
- 7. The Quorum fixed for the said Meeting was 50 (Fifty) Unsecured Creditors in number, present either in Person or through Proxy or through Authorised Representatives. At the time fixed by the Hon'ble Tribunal at 12:00 p.m. for the Meeting, the Quorum was present and the Meeting was attended by 157 (One Hundred Fifty Seven) Unsecured Creditors in number either in Person or through Proxy or through Authorised Representatives. The list of Unsecured Creditors who were present at the Meeting either in Person or through Proxy or through Authorised Representatives is attached herewith as an Annexure B.
- 8. After the announcement of declaring the Meeting open was made by the Chairperson, the following procedure for voting and scrutinizing was adopted in the Meeting:-

a. The Polling Papers were provided to all the Unsecured Creditors who has attended the Meeting.
