Review Report To, The Board of Directors, M/s. Maharashtra Corporation Limited

We have reviewed the accompanying statement of unaudited financial results of M/s Maharashtra Corporation Limited (the "Company"), for the nine months and quarter ended 31st December, 2023 ("the Statement") being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
