Pursuant to Regulation 30 read with Para-A of Part-A of Schedule-III of the SEBI (LODR) Regulations, 2015, it is to inform that National Stock Exchange of India Limited (NSE) and BSE Limited (BSE) have levied fine of Rs.5,42,800 (incl. GST) by both the stock exchanges on the Company for the non-compliance with Regulation-17(1) i.e., half of the Board was not independent, for the quarter ended 31st December, 2023.

The Company has clarified to, NSE and BSE that MOIL Limited is a Government Company as per provisions of the Section 2(45) of the Companies Act, 2013. As per provisions of the Companies Act, 2013 and Articles of Association of the Company, the President of India vests with the power to appoint Directors (including Independent Director) on the Board of MOIL. All Directors in MOIL are appointed by the Government of India (GOI) through its Administrative Ministry i.e., Ministry of Steel (MoS) and MOIL has no role to play in the appointment of any Director unless nominated by the Government of India.

Further, it is also clarified that the aforesaid non-compliance regarding the composition of the Board was neither due to any negligence/default by the Company nor within the control of MOIL's management and continuous efforts were also made to meet the compliance requirements. GoI has been requested for appointment of requisite number of Independent Directors on the Board of the Company.

The fine levied by NSE and BSE has no impact on the financial, operation or other activities of the Company.

Considering the above position, NSE and BSE have been requested to waive-off the above mentioned fine levied on the Company.
