Dear Sir,

I, Neelesh Kumar Jain, Company Secretary in Practice (FCS:5593/ CP No. 5233), have been appointed as the Scrutinizer pursuant to Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 by the Board of Directors of ORIENT ELECTRIC LIMITED ('Company') vide its resolution dated 28thJanuary 2019 to conduct the postal ballot and e-voting process of the Company in connection with passing of the resolutions for the Businesses stated in the notice of Postal Ballot dated 28thJanuary, 2019.

I submit my report as under:

- The Company has completed the electronic transmission and physical dispatch of Postal Ballot Notice along with the explanatory statement, the Postal Ballot Form and the pre-paid business reply envelope on 08 February 2019to its members whose names appeared in the register of members/ list of beneficial owners as on 01st February 2019 ("Cut-off date").
- 2. On the basis of the register of members/ list of beneficial owners made available by the Registrar and Share Transfer Agent of the Company i.e MCS Share Transfer Agent Limited, the Company had dispatched the Postal Ballot Notice, along with the postal ballot form /e-voting instructions, to the Members of the Company.
- 3. The Company has also provided the facility of e-voting through e-Voting website of National Securities Depository Limited ("NSDL"), available <u>atwww.evoting.nsdl.com</u>, to its Members.
- 4. The voting period commenced on 12 February 2019 at 10:00 AM and concluded on 13th March 2019 at 5:00 PM for voting through physical postal ballot form as well as through e-voting.
- 5. The Members holding shares as on the Cut-off date were entitled to vote on the proposed resolutions as set out in the Notice of Postal Ballot dated 28thJanuary 2019 of the Company.
- 6. The Postal Ballot Forms received were kept under safe custody before commencing the scrutiny of such Postal Ballot Forms.



- 7. Particulars of all the Postal Ballot Forms received from the Members have been entered in a separate register maintained for this purpose.
- 8. I did not find any defaced or mutilated Postal Ballot Papers.
- Also, for e-voting, the votes were unblocked at 5:00 PM on Wednesday the 13th March 2019 in the
 presence of two witnesses Ms. Priya Gupta and Ms. Madhuri Rawat who are not in the employment
 of the Company and who have signed below in confirmation of the votes being unblocked in their
 presence.
- 10. The details of e-voting, *inter-alia*, containing the list of Members who voted "For" or "Against" on each of the resolutions that were put to vote were generated from the e-voting website of NSDL i.e., <u>www.evoting.nsdl.com</u>.
