According to complainant's advocate Vishrut Jani, the case involves allegations of forging a power of attorney in a land fraud case in Chardkeds

The FSL took more than three years to verify the signatures on the documents in question. To resolve the issue, the HC ordered a meeting last month, but the ACS (Home) did not attend it. The court ordered the meeting to expedite FSL analysis and reports by filling up vacant expedite FSL analysis and reports by filling up vacant posts so that investigations are completed early. Ahmedabad: It was only after the Gujarat high court castigated the police for showing the "superpower of khaki" by

The police seized the gadgets after Jadeja was booked in a land-grabbing case. The FIR was filed with the Dhandhuka police just one day before Jadeja's scheduled interview for the Accounts Officer Class-I position, organized by the Gujarat Public Service Commission (GPSC), in April. Given the seemingly unrelated nature of these allegations to the land-grabbing case, Jadeja sought court intervention to recover his electronic gadgets. The court had issued an order on May 11 for the police inspector to gaggéts. Despite this, the inspector did not return the confiscated items to Jadeja. His advocate, Hemang Shah, complained about this in the high court. On hearing the matter, Justice J C Doshi summoned the inspector, saying, "This is nothing but the superpower of the khaki." The court also demanded an explanation from the superintendent of police about the inspector's behaviour.
