- 1. I. Ashish C. Doshi, Partner of SPANJ & ASSOCIATES, Company Secretaries in Practice having office at TF/1. Anison Bldg, 3rd Floor, Swastik Soc., Nr. Stadium Circle, C. G. Road, Navrangpura, Ahmedabad-380 009, have been appointed as Scrutinizer by the Board of Directors of Rushil Decor Limited ("the Company") for the purpose of scrutinizing the process of voting through electronic means ("e-voting") on the resolutions contained in the notice dated 26th October, 2023 ("Notice") issued in accordance with General Circular No. 14/2020, 17/2020, 22/2020, 33/2020, 39/2020, 10/2021, 20/2021, 03/2022, 11/2022 and 09/2023 dated 8th April 2020, 13th April 2020, 15th June 2020, 28th September 2020, 31st December 2021, 08th December, 2021, 5th May 2022, 28th December 2022 and 25th September 2023 respectively, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"). Government of India, calling the Extra Ordinary General Meeting of its Equity Shareholders ("the Meeting" / "EGM") through VC / OAVM. The EGM was convened on Saturday, 18th November, 2023 at 11:15 a.m. (IST) through VC / OAVM.
- 2. The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have to scrutinize:
 - (i) process of e-voting remotely, before the EGM, using an electronic voting system on the dates referred to in the Notice calling the EGM ("remote e-voting"); and
 - (ii) process of e-voting at the EGM through electronic voting system ("e-voting").
- 3. The compliance with the provisions of the Companies Act. 2013 and the Rules made there under, MCA Circulars and SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("LODR") relating to voting through electronic means (by remote e-voting and e-voting at EGM) the resolutions proposed in the Notice of the Extra Ordinary General Meeting of the Company is the responsibility of the management. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems. Our responsibility as a Scrutinizer for e-voting process is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" if any, the resolutions contained in the Notice, based on the reports generated from the electronic

voting system provided by National Securities Depository Limited (NSDL) and documents furnished to me electronically by the Company and/or NSDL for my verification.

- 4. In accordance with the Notice of Extra Ordinary General Meeting sent to shareholders, the voting through electronic means/ remote e-voting started on Wednesday, 15th November, 2023 (9:00 am) and ended on Friday, 17th November, 2023 (5:00 pm).
- 5. The Equity Shareholders holding shares as on the "cut off" date i.e. Saturday, 11th November, 2023 were entitled to vote on the proposed resolutions (Item no. 01 as set out in the Notice of the Extra Ordinary General Meeting of the Equity Shareholders of Rushil Decor Limited) the Company.
- . 6. The votes cast were unblocked on Saturday, 18th November, 2023 after the conclusion of the EGM and was witnessed by two witnesses, Ms, Kinjal Shah and Ms. Bansari Shah who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.

- 7. Thereafter, the details containing *inter-alia*, list of equity Shareholders, who voted "For" and "Against", were downloaded from the remote e Voting website of National Securities Depository Limited (https://www.evoting.nsdl.com/). Based on report generated by NSDL and relied upon by us, data regarding the remote c-voting was scrutinized on test check basis.
- 8. After the time fixed for closing of the e-voting by the Chairman, the electronic system recording the e-voting (e-votes) was locked by NSDL under my instructions. The e-voting system was scrutinized on test check basis. The e-votes were reconciled with the records maintained by the Company / NSDL and the authorizations lodged with the Company/ NSDL on test check basis. The e-votes cast were unblocked on Saturday. 18th November. 2023 after the conclusion of the EGM.
