By way of the said order dated 04.09.2023, the Hon'ble NCLT had held the company petition to be maintainable and dismissed C.A. No. 31 of 2023 filed by Respondents No. 5 and 12 challenging the maintainability of the company petition. When the appeal was taken up before the Hon'ble NCLAT on 20.11.2023, the counsel appearing on behalf of the Appellants sought permission to withdraw the appeal. The Hon'ble NCLAT permitted the Appellants to withdraw their appeal, and accordingly, dismissed the appeal as withdrawn. A copy of the order dated 20.11.2023 (uploaded today i.e., 22.11.2023) is annexed herewith, for information and record.
