5. Password details for shareholders other than Individual shareholders are given below:

The following explanatory statement pursuant to Section 102(1) of the Act, sets out all material facts relating to the special business mentioned in the accompanying notice of the Postal Ballot.

Item No. 1

M/s. P. Murali & Co, Chartered Accountants, (Registration number: 007257S), the Auditors of the Company have resigned as statutory auditors of the Company with effect from 14th November, 2023 due to pre-occupation, thereby resulting in a casual vacancy in the office of Auditors.

In terms of the provision of Section 139(8) of the Companies Act, a casual vacancy arising due to resignation of Auditor can be filled by the Board of Directors within thirty days and such appointment shall also be approved by the company at a general meeting convened within three months of the recommendation of the Board and the Auditor shall hold the office till the conclusion of the next annual general meeting.

In order to fill up the casual vacancy caused by the resignation of the auditors, the Board of Directors of the Company ('the Board'), upon recommendation of the Audit Committee ('the Committee') at its meeting held on 11th December, 2023, have appointed M/s.
