Sub: Outcome of 13<sup>th</sup> CoC Meeting of M/s. Southern Online Bio Technologies Limited scheduled on 17<sup>th</sup> June, 2019.

With reference to the subject cited above, I would like to inform you that the following items were discussed in the 13<sup>th</sup> CoC meeting of Southern Online Bio Technologies Limited. Details are as below:

1. After checking of the quorum for the meeting, RP has given summary of outcome of the 12<sup>th</sup> CoC meeting and asked for the confirmation from the members of the CoC. One of the items mentioned in the Minutes of the 12<sup>th</sup> CoC meeting i.e. Arbitration proceedings, discussed on this in detail and decided by the CoC to lodge a complaint to the IRDA with all the findings, communications with the NIC at the time of disbursement of claim amount and circular of IRDA against the NIC by the Resolution Professional.

Apart from the above, there were no changes in the minutes of the 12<sup>th</sup> CoC meeting and approved accordingly by the members of the CoC.

2. Discussed agenda items of the 13<sup>th</sup> CoC meeting, members of the CoC informed that the decision of their higher officials on the approval of the resolution plan or to go to liquidation has depend on the outcome of the JLM meeting on the forensic auditors report. Due to the time constraint for completion of CIRP period of 270 days, RP has enquired about the final date to get their decision. Finally it's decided to get their approval on or before 25<sup>th</sup> June, 2019 without further delay.

3. Discussed and agreed on Performance Guarantee timeline has reduced from 8 days to 3 days and need to get the concerns from the Resolution Applicants on the same.
