Asif Ali Zardari likely to become Pakistan president

ISLAMABAD: As PML-N, PPP, MQM, PML-Q, PFF and BAP have announced to form a coalition government in the Centre, PPP co-chairman Asif Ali Zardari is likely to become the President of the country for the second time, local media reported. The parties have announced to form a government in the Centre on the lines of the Pakistan Democratic Movement government. PML-N leadership has agreed to support Zardari for the post of president in return for PPP's support to Shehbaz Sharif for the Prime Minister's post.

Elderly PIO motel owner shot dead

Washington: A 76-year-old Indian-origin motel owner was shot dead by a customer in the US state of Alabama following an altercation over a room, the latest in a string of tragedies to shock the community in the country. Provin Raajbhai Patel, who owned Hillcrest Motel in Sheffield, was shot dead last week according to Sheffield Police Chief Ricky Terry. William Jeremy Moore, 34, was arrested for the shooting death of Patel. WFTV-TV a television station in Jacksonville, reported. Officers said the shooting was the result of an altercation that occurred when Moore came to the property looking to rent a room. Moore pulled a gun and shot Patel, Terry said.

Indian sentenced for stealing \$450K

New York: An Indian national hailing from Haryana has been sentenced to more than four years in prison for his role in stealing \$150,000 from an elderly woman in the US state of Montana. Sukhdev Vaid, 24, admitted targeting elderly Americans via an international computer-hacking scheme that resulted in more than \$1.2 million in total losses, US Attorney Jesse Ludwick said on Wednesday. The court ordered that upon his release on custody, Vaid will be remanded to the Bureau of Customs and Immigration Enforcement for deportation. He asked him to pay \$12,236,470 restitution.

Albanese first Aussie PM to get engaged in office

Melbourne: Anthony Albanese has become the first Australian prime minister to get engaged while in office, revealing on Thursday that his partner accepted his marriage proposal on Valentine's Day. He and Julie Haydon, a financial services professional, have been together for three years. Albanese said he proposed on a balcony of his office residence, known as the Lodge, following a romantic dinner at an Italian restaurant.

NATO chief warns against dividing the US and Europe

AP/BRUSSELS: The head of NATO warned member countries on Thursday against allowing a wedge to be driven between the United States and Europe, as concerns grow about Washington's commitment to its allies should Donald Trump return to office. Faced with a war in Ukraine that is draining military and financial resources, and with a US package of support held up by infighting in Congress, European leaders and senior officials have warned that Europe must invest more in its armies.

CANADA, OZ, NZ CALL FOR IMMEDIATE CEASEFIRE AHEAD OF RAFAH ASSAULT

AGENCIES/SYDNEY

The leaders of Canada, Australia and New Zealand on Thursday called for an immediate humanitarian ceasefire in Gaza, according to a joint statement released in response to reports about Israel's planned military operation in Rafah.

"We are gravely concerned by indications that Israel is planning a ground offensive into Rafah."

"A military operation into Rafah would be catastrophic," the statement by the prime ministers of the three countries said, as reported by Reuters. "An immediate humanitarian ceasefire is urgently needed."

The protection of civilians is paramount and a requirement under international humanitarian law, the statement said. "Palestinian civilians cannot be made to pay the price of defeating Hamas."

Imran picks Omar Ayub as PTI candidate for PM's post

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Asad Qaiser on Thursday picked Omar Ayub Khan as the candidate for Prime Minister's post.

Addressing the media outside the Adiala jail following his meeting with Imran Khan, former National Assembly Speaker Qaiser said he has been tasked with approaching all political parties to form the next government.

Israeli airstrikes kill 10 Lebanese civilians in one day

AP/BEIRUT: The civilian death toll from two Israeli airstrikes in Lebanon has risen to 10, Lebanese media reported Thursday, making the previous day the deadliest one in more than four months of cross-border exchanges.

The Lebanese militant group Hezbollah has vowed to retaliate for the strikes, which hit in the city of Nabatiyeh and a village in southern Lebanon, just hours after projectiles from Lebanon killed an Israeli soldier.

In Nabatiyeh, the strike knocked down part of a building, killing seven members of the same family, including a child, the state-run National News Agency said. A boy initially reported missing was found alive under the rubble. Initial reports had said four people were killed.

In the village of Souaneh, a woman and her two young children were killed. The Lebanese civilian death toll included six women and three children.

Vatican condemns 'carnage', disproportionate response in Gaza

AP/ROME: Israel has formally complained after a senior Vatican official spoke of "carnage" in Gaza and what he termed a disproportionate Israeli military operation following the October 7 Hamas attacks.

The Israeli Embassy to the Holy See called the comments by Cardinal Pietro Parolin, the Vatican secretary of state, "deplorable."

In a statement Wednesday, the embassy said Parolin had not considered what he called the relevant facts in judging the legitimacy of Israel's actions.

Speaking Monday at a reception, Parolin condemned the October 7 Hamas attacks against Israel and all forms of antisemitism. But he questioned Israel's claim to be acting in self-defence by inflicting "carnage" on Gaza.

Israel has objected previously to the Vatican position on the war, including when Pope Francis spoke about "terrorism," Francis, who speaks daily via video conference to a Gaza parish housing Palestinian civilians, has since tried to be more balanced in his comments.

UK slips into recession derailing Sunak's pledge to generate growth

INDS/LONDON

The UK has slipped into recession just months ahead of a general election, official figures showed on Thursday, derailing Prime Minister Rishi Sunak's pledge to generate economic growth, the media reported.

The GDP fell 0.3 per cent in the final three months of 2023, following a 0.1 per cent contraction in the July to September period, the Office for National Statistics (ONS) said.

A recession is commonly defined as two consecutive quarters of contraction. "All the main sectors fell in the quarter, with manufacturing, construction and wholesale being the biggest drags on growth, partially offset by increases in hotels and rentals of vehicles and machinery," ONS director of economic statistics Liz McKewon said in a statement, CNN reported.

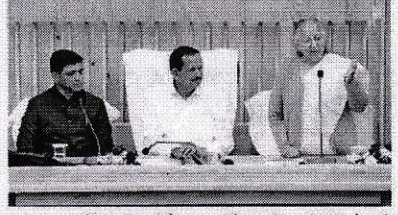
