In furtherance thereof, pursuant to the Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in accordance with the requirements of subclause 16 (g) of Clause A of Part A of Schedule III of Listing Regulations.

The undersigned hereby intimates that the following matters were discussed in the Eleventh meeting of the Committee of Creditors (CoC) held on 02nd November 2023.

- 1. Minutes of the Tenth Meeting of the Committee of Creditors was read and confirmed as no observations was received on the Draft Minutes circulated to the members of the Committee of Creditors.
- 2. RP updated the Committee of Creditors on the CIRP Status of the Company.
- 3. RP also updated COC that Resolution Plan has been approved by COC at its 10th Meeting of Committee of Creditors and is scheduled for hearing on 08th December 2023.
- 4. RP appraised to the Committee of Creditors that IA has been filed against Tvastra Technologies and Engineers Private Limited for transfer of Pressmart shares without consideration.
- 5. RP also appraised COC that one IA has been filed for taking possession of Vehicle and one of the Respondents Mr. Rajesh Katragadda is ready to comprise.

- 6. It was also informed to COC that Corporate Debtor received request from NMC for renewal of BG expired on 08th October 2023. RP requested HDFC Bank on renewal of BG of Rs. 4.47 Crores on 11th October 2023 and 17th October 2023. RP also appraised COC that if not renewed then it will be invoked.
- 7. Also it was appraised to COC that still EMI's are being debited for Car loan. Hence it was asked to HDFC Bank for reversal of the same.
- 8. Also Resolution Professional placed for approval CIRP expenses incurred during the period July to October 2023 before Committee of Creditors which includes reversal of EMI.
- 9. RP also shared the probable expenditure that may be incurred upto March 2024 before Committee of Creditors.
