Dear Sir,

I, S. Samdani, Partner, Samdani Shah & Kabra, Company Secretaries, have been appointed as a scrutinizer by the Board of Directors of **Paushak Limited** (the Company), for scrutinizing postal ballot voting including voting by electronic means in respect of the passing of the resolution (business) contained in the notice dated January 24, 2018 through postal ballot.
