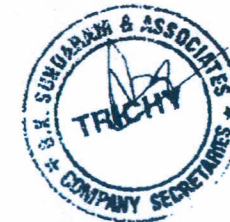

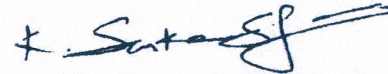

2. The e-voting period remained open from 25<sup>th</sup> February 2019 (10.30 am) to 27<sup>th</sup> March 2019 (5.00 pm) through e-voting services provided by National Securities Depository Limited (NSDL).
3. The e-votes were unblocked through the menu provided in the NSDL website on 27<sup>th</sup> March 2019 after the closing hour of 5.00 P.M. in the presence of two witnesses viz Mr. B.RAMAMURTHY and Mr. K. 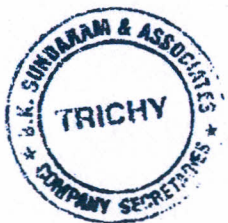

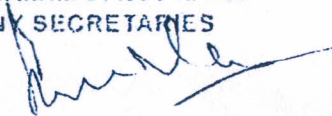
