Thereby, the board meeting held on 14<sup>th</sup> August, 2023 for discussion on financials for the quarter ended 30<sup>th</sup> June, 2023 was called to be adjourned by the chairman to 17<sup>th</sup> August, 2023 and the adjourned meeting was cancelled due to want of quorum.

All the queries were collectively discussed and resolved later, and the revised financials for the year ended 31<sup>st</sup> March, 2023 along with first quarter financials for the period ended 30<sup>th</sup> June, 2023 were approved at their meeting held on 04<sup>th</sup> September, 2023 and the same was disclosed to the exchange.
