# Govt imposes 50% duty on exports of molasses from Jan 18

**Times News Network**  
New Delhi: The government has imposed 50% duty on exports of molasses, a by-product of sugarcane used as raw material for ethanol manufacturing, from January 18. It also extended the existing concessional duty rates on imports of crude and refined edible oils, palm, soyabean and sunflower, by one year till March 31, 2025.

While the first move will increase the availability of molasses in the domestic market, the second move aims to ensure edible oils are available at the current affordable rate. The lower import duty was to expire in March this year. The basic import duty on refined soyabean oil and sunflower oil was cut to 12.5% from 17.5%, in June last year.

The finance ministry notified the steep export duty on molasses amid concerns over the fall in sugarcane and sugar production due to erratic monsoon this year, particularly in Maharashtra and Karnataka. Government had also restricted the use of sugarcane juice/ syrup for production of ethanol to avoid any shortage of sugar, and had also urged the sugar mills to use maximum C-Heavy molasses for ethanol production.

# 'Consider right of foetus to life, recall MTP order'

**Govt Moves HC After Abortion Allowed At 29 Weeks**

New Delhi: Union government has approached Delhi High Court seeking a reconsideration of an order allowing a widow to terminate her 29-week pregnancy, arguing that the unborn child has a fair chance of survival. HC has agreed to review the recall plea later this week, instructing AIIMS to present a report detailing the physical and mental health of the woman and foetus.

AIIMS, where the woman is under examination, has also approached HC and supported government's stand to protect the unborn infant's right to life, while suggesting that continuing the pregnancy for another two-three weeks would be beneficial for mother and child. It submitted that "foeticide in this case is neither justified nor ethical as foetus is completely normal".

In a plea submitted on January 4, HC had granted permission to the widow, who was dealing with depression, to undergo an abortion due to potential adverse effects on her mental health.

The woman, married in February 2023, discovered her pregnancy at 20 weeks on October 19. Suffering extreme trauma, she decided in December not to proceed with the pregnancy

# HC allows MTP to let rape survivor live with dignity

Chandigarh: Punjab and Haryana HC has granted permission for medical termination of pregnancy (MTP) of a minor rape survivor, observing that the "tough" decision was necessary to allow the girl to live with dignity.

The ruling by Justice Vinod S Bhardwaj came on a petition filed by a woman from Punjab's Mohali, who contended that her daughter became pregnant after she was abducted and raped, and was not in a situation to raise the child.

# Conspiracy theories swirl as UK cops warn Sikhs of death threats

**London:** Several British Sikhs say they have received "threat to life" notices, also known as Osman warnings, from the British police alerting them of immediate danger.

This has fuelled conspiracy theories that India could be behind the threats, given the court case against Nikhil Gupta in the US regarding an alleged plot to kill Khalistani separatist Gurbatwant Singh Pannun, disrupted a terrorist by India, with Gupta allegedly recruited by an Indian government employee, as well as allegations made by Canadian Prime Minister Justin Trudeau about a "potential link" between Indian government agents and the assassination of Sikh separatist Hardeep Singh Nijjar.

An Osman warning is a police warning of a death threat. It is used when there is intelligence of the threat but not enough evidence to justify an arrest. The name derives from the Osman family which won a landmark judgment that police breached Ali Osman's (a businessman who was shot dead) right to life as they had the information needed to deal with the threat.

One Sikh man, whose brother and father were also handed Osman notices, told the UK's Times he initially thought it came from "religious fundamentalists in the West Midlands" but following on from the Nijjar and Pannun cases, as well as a belief that pro-Khalistan separatist Avtar Singh Khandha was poisoned, he now believes there could be an "Indian government connection".

However, one Sikh told TOI that he believed the threats came from a radical UK Sikh outfit and there was no Indian government involvement.

Dabinderjit Singh, principal adviser of the Sikh Federation (UK), also played down the role of India in these notices, saying: "Osman reports are often to do with domestic gang violence." But he added: "Transnational repression by the Indian government is real and British Sikhs are being targeted."

# Nusrat plea nixed, must make court appearance

**Kolkata:** The Alipore sessions court has turned down a revision petition by Trinamool Basirhat MP Nusrat Jahan praying to the court to dispense with her appearance in person in a cheating and criminal breach of trust case.

"I find that there is no firmity, irregularity or illegality in the court order; nor is there anything prejudicial to the applicant so as to justify any interference in the said order by the court," additional sessions judge Ansuman Chattopadhyay held.

The MP had moved the sessions court against an order of the judicial magistrate on April 5 last year. The magistrate had allowed Jahan's application to dispense with her personal appearance on the condition that she appear on one occasion and file an affidavit and bond, particularly during the framing of charges.

Jahan moved the sessions court seeking removal of the conditions, on the grounds that her work as an MP and actor meant she had to travel extensively. The Basirhat MP, in her revision petition, stated that the impugned order was a gross violation of the judicial process and would ultimately lead to harassment and unjust persecution of the applicant.

TMC spokesperson Kunal Ghosh said: "This is a legal process and a personal issue of Nusrat Jahan. We will not comment on that at this stage."

Jahan had been a director of 7 Sense Infrastructure Pvt Ltd, which allegedly took money from 429 home buyers promising them flats at Rajarhat but failed to deliver them.

# 'Insensitivity to Bhopal gas victims': 6 officials charged with contempt

**Bhopal:** Madhya Pradesh High Court has issued a strongly worded chargesheet against former state chief secretary Iqbal Singh Bains, two secretaries of the Union government and three other senior officials in a contempt case over non-compliance of court orders for medical care of Bhopal gas tragedy victims, saying that their conduct shows "insensitivity towards gas victims".

Apart from Bains, those issued a chargesheet include Union health secretary Rajesh Bhushan, Union chemical & fertilisers secretary Arti Ahuja, Atomic Council for Medical Research's senior deputy director R Rama Krishnan, former director of Bhopal Memorial Hospital & Research Centre (BMHRC) Prabha Desikan and director of National Institute for Research on Environmental Health (NIREH)

Dr Rajnarayan Tiwari. The court has already convicted MP additional chief secretary, health & gas relief, Mohd Suleman, and two officials of National Informatics Centre (NIC) in the contempt petition filed by NGOs working among gas victims.

A division bench of justices Sheel Nagu and DN Mishra said, "It is obvious that despite the lapse of more than 10 years, you respondents have demonstrated no urgency or sincerity in complying with directions of Supreme Court as well as of this court, thereby leaving gas victims in the lurch. You have tried your best to render the concept of PIL nugatory by dragging your feet on compliance. This court does not see any good reason behind this laxity by you except for insensitivity towards gas victims."

The court observed that the respondents have "willfully shown disobedience" to SC and HC directions.

# ISF moves HC for rally nod

**Kolkata:** ISF on Tuesday moved the Calcutta High Court after police denied permission to its proposed annual gathering in front of Victoria House at Esplanade, reports **Subrata Chattoraj**.

Stating the matter in the court of Justice Jay Sengupta, the ISF counsel referred to Trinamool holding a rally at the venue every year on July 2. Justice Sengupta allowed ISF to file a petition, which will likely be taken up on Wednesday.

# SC directs UP to clean sealed Gyanvapi tank

**New Delhi:** The Supreme Court on Tuesday asked the UP government to clean the wuzu water tank, which was sealed on SC orders after purported discovery of a Shivaling during a court-mandated survey in May 2022, under the supervision of Varanasi district magistrate.

A bench headed by CJI D Y Chandrachud accepted the tank cleaning plea of Hindu plaintiffs, who have filed a suit seeking right to worship inside Gyanvapi mosque, believed to be built in the 17th century on the Kashi Vishwanath temple after partial demolition of it, after the mosque management committee supported it.

Appearing for the Hindu side, senior advocate Madhavi Divan said the tank, unused since May 16, 2022 after the discovery of the Shivaling, is emitting a foul smell because of dead and rotten fishes in it. Mosque management committee through senior advocate Huzefa Ahmad said a similar plea by the Muslim side is pending before a Varanasi court. The bench directed the state authorities to undertake the cleaning task under supervision of the district magistrate. The trial court ordered sealing of the wuzu area on May 16, 2022 and the order was confirmed by the SC a day later.

# DNA profiling of unclaimed bodies: SC seeks govt view

**New Delhi:** Ten years after initiating proceedings on a PIL seeking DNA profiling of all unidentified bodies, the Supreme Court was back at square one as it sought Centre's response afresh on a PIL on the same issue — DNA profiling of unidentified bodies — after being told that a bill on this had been withdrawn from Parliament, reports **Dhananjay Mahapatra**.

In 2014, SC had issued notices to ministry of home affairs, CBI and secretary, department of scientific and industrial research, on a PIL by Lokniti Foundation, which had said absence of a national DNA database was impeding identification of nearly 40,000 bodies found every year.

After dealing with the PIL for four years, the SC on May 1, 2018 had disposed of it as government had promised to bring a bill. On July 24 last year, government withdrew from LS the DNA Technology (Use and Application) Regulation Bill, 2019, citing the 2022 law. But opposition parties criticised the move saying Centre did not want to incorporate privacy safeguards suggested by the standing committee.

# Snatcher falls off bike, victim calls emergency number

**Gurgaon:** A snatcher who was seriously injured after losing balance on his bike got prompt medical attention — courtesy the man whose cellphone he had stolen just moments earlier at IMT Manesar on Monday.

The snatcher, a youngster, was critically injured and has been operated on. He is yet to regain consciousness, police said on Tuesday.
