Pursuant to Regulation 30 of the Listing Regulations and in continuation to our letter dated August 14, 2023, it is informed that the that the suit filed by Metropolis Bramser Lab Services (Mtius) Limited (“Metropolis Bramser”, step-down WOS of the Company) before the Supreme Court of Mauritius has been dismissed. The details as required under SEBI Circular No SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July 2023 are provided below.

The details of any change in the status and / or any development in relation to such proceedings	The Hon’ble Supreme Court of Mauritius through its judgment dated 26 th April 2024 (received on 30 th April 2024 through our legal counsel) dismissed the Plaint filed by Metropolis Bramser of MUR 150,000,000/- (INR 270,450,000/- approx.) as compensation for damages and prejudice suffered. However, the judgment is silent on some valid issues raised by Metropolis Bramser. The above judgment has no financial impact on the Company’s financial statement as no benefits were taken in books in anticipation of damages. Metropolis Bramser will file an appeal before Court of Civil Appeal, basis evaluation of the case.
