I, CS Manish L. Ghia, Partner, M/s. Manish Ghia & Associates, Company Secretaries, Mumbai was appointed as Scrutinizer by the Board of Directors of the Company to scrutinize the voting through Postal Ballot (physical and e-voting) for seeking approval of members for the following matter:

- a. Reclassification of Mr. Nawal Kishore Singh from promoter group category to public category.
- 1. The Postal Ballot and e-voting process has been completed and now I submit my report as under:
- 1.1 The Company completed the dispatch of Postal Ballot Notice dated 8th February, 2019 along with Postal Ballot Form and self-addressed business reply envelope to its members through permitted mode on Thursday, 16th May, 2019, whose names appeared in the Register of Members/List of Beneficiaries maintained by the Depositories as on the cut-off date being Friday, 10th May, 2019.

- 1.2 As per provisions of applicable rules of Companies (Management and Administration) Rules, 2014, the Company has published advertisement about completion of dispatch of Postal Ballot Notice and providing E-voting facility in English Newspaper "Business Standard" and Marathi Newspaper "Mumbai Lakshadeep" on Friday, 17th May, 2019.
- 1.3 Particulars of all the Postal Ballot Forms received from the Members have been entered in a register separately maintained for the purpose.
- 1.4 All Postal Ballot Forms received upto 5.00 p.m. on Saturday, 15th June, 2019, being the last date and time fixed by the Company for receipt of the Postal Ballot Forms, are considered for my scrutiny.
- 1.5 The Postal Ballot Forms were duly opened in my presence and scrutinized, including verification of signature of the shareholder(s). The Shareholding was matched/confirmed with the Register of Members of the Company/List of Beneficiaries maintained by the Depositories as on the cut-off date i.e. Friday, 10th May, 2019.
- 1.6 The e-voting period commenced on Friday, 17th May, 2019, 9:00 a.m. (IST) onwards and ended on Saturday, 15th June, 2019 at 5.00 p.m. (IST). The Company has availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting Postal Ballot Process.
