I, Swaran Kumar Jain of M/s. Swaran Jain & Associates., Company Secretaries, Delhi, appointed by the Board of Directors of DCM Shriram Industries limited (the Company) as the Scrutinizer for the purpose of scrutinizing the Postal Ballot voting conducted by remote e-voting pursuant to Section 108 and 110 of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014, ("the Rules") in a fair and transparent manner on the resolutions contained in the postal ballot notice dated February 12, 2024 ("Notice") issued in accordance with the Act and Rules read with General Circulars No.14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020, 9/2023 dated September 25, 2023 ("MCA Circulars"), applicable provisions of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India ("ICSI").



The management of the Company is responsible to ensure compliance with the requirements of:
