Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the Company has received two Orders from the Office of the State Tax Officer, Cuttack, Odisha, under Section 73 of the Central Goods and Services Tax Act, 2017 and Odisha Goods and Services Tax Act, 2017, as under:

- (i) Order dated 9<sup>th</sup> April, 2024 disallowing Input Tax Credit (ITC) claimed under Input Service Distributor (ISD) invoices and raised a demand of tax of Rs.16.95 lakhs, interest of Rs.17.97 lakhs and penalty of Rs.1.70 lakhs.
- (ii) Order dated 9<sup>th</sup> April, 2024 raising a demand of tax of Rs.2.20 lakhs on issues relating to E-way bills, interest of Rs.2.09 lakhs and penalty of Rs.0.30 lakh.

The Company is in the process of filing an appeal against the said Orders.

There is no material impact on the financials, operations or other activities of the Company due to these penalties.

The information as required under Clause 20 of Para A of Part A of Schedule III of the SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/ 2023/123 dated 13<sup>th</sup> July 2023 is enclosed in the Annexure.
