- 1. We have reviewed the accompanying Statement of unaudited financial results of **POPULAR** ESTATE MANAGEMENT LIMITED ("the Company"), for the quarter and Nine months ended December 31, 2023 ("the December"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 2. The above claim is subject to legal proceeding at various appellate authorities. The Company is contesting the above demand and the management including its tax advisors believes that its position will likely be upheld in the appellate process. The management believes that the ultimate outcome of these proceedings will not have a material adverse effect on the Company's financial position and results of operations.

- 3 The company is having substantial interest in two associated partnership firms. The company doesn't prepare consolidated financial statements by applying equity method of accounting under Indian Accounting Standard (Ind-AS) -28 "Investments in Associates and Joint Ventures" as there are no operations in the said partnership firms during the period covered by this financial results, and no profit / loss is attributable to the company.
- 4 The company operates only in one segment i.e. Infrastructure and hence there is no other primary reportable segment as required by Indian Accounting Standard (Ind AS) 107 "Segment reporting".
- 5 The figures for the quarter ended December 31, 2023 & December 31, 2022 are balancing figures between the unaudited figures in respect of the respective nine-months ended December 31, 2023 & December 31, 2022 and the unaudited published year to date figures upto second quarter ended September 30, 2023 & September 30, 2022 respectively, which were subject to limited review.
- 6 Previous Periods' / Years' figures have been re-grouped / re-classified where necessary to make it comparable with the current period.
- 7 In view of uncertainity about sufficient future taxable income against which this Deferred Tax Asset/Liabilities can be realized, the same has not been recognised.
