

## <u>UCWL Announces Major Expansion: More than Doubles Cement</u> <u>Capacity</u>

Udaipur Cement Works Limited (UCWL) achieved a significant milestone in its ongoing Expansion Project with the commissioning of an additional 2.50 Million Tonnes Per Annum Cement Grinding Capacity at its existing location at Udaipur in Rajasthan (India).

Under the dynamic leadership of Smt. Vinita Singhania, Chairperson, UCWL has seen remarkable growth in past few years. Smt. Vinita Singhania expressed her excitement, stating, "This expansion marks a monumental achievement for UCWL. Our total Cement Grinding capacity has more than doubled to 4.70 Million Tonnes Per Annum from 2.20 Million Tonnes Per Annum."

UCWL had earlier in October 2023 commissioned an additional Clinker Line of 1.50 Million Tonnes Per Annum whereby the Company's Clinker Capacity was doubled to 3.00 Million Tonnes Per Annum from 1.50 Million Tonnes Per Annum.

UCWL has been a pioneer in the promotion of various Green Initiatives. Last year, the Company had installed a first of its kind in the State of Rajasthan & the only one in the entire Indian Cement Industry a Floating Solar Power Plant of 1 MWp at its Mines. During the previous Quarter, the Company also doubled its Waste Heat Recovery Power Capacity from 6 MW to 12 MW. This has enabled UCWL to achieve a Green Energy share of more than 50% in total electrical energy consumption.
