With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Commercial Tax Officer (Audit) – 3.5, DGSTO-3, Bangalore, for the period April 2018 to March 2019 imposing demand of INR 11,87,308/- (Tax INR 5,89,234/-, interest INR 5,39,150/- and penalty of INR 58,924/-) under Goods and Service Tax Act,2017.

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellant authorities.
