2. Upon the recommendation of the Audit Committee, the Board has subject to the approval of shareholders approved the appointment of M/s. Mukul Garg & Associates, Chartered Accountants (FRN-019503C) as new Statutory Auditors of the Company to fill the casual vacancy arised due to the resignation of M/s. Aggarwal Pawan & Associates (FRN-031570N).
