he Congress manifesto for the Madhya Pradesh Assembly elections, released on Tuesday, is abun-dant with welfare measures for farmers, women, and young-sters. It has also attempted to embrace Hindu cultural tradiembrace Hindu cultural tradi-tions, such as renewing the par-ty's commitment to cow pro-tection, promising a "4100 crore package" for constructing a Narmada pilgrimage corridor and rebuilding old temples. Madhya Pradesh has 230 Assembly seats, and its 56.13 million electorate will vote on November 17 to elect a fresh House. Congress state unit presi-dent, its chief ministerial face, Kamal Nath, released the Hi6-page manifesto in Bhopal, where he said his government would work to ensure the state gets its own Indian Premier

where he said his government would work to ensure the state gets its own Indian Premier League team. Senior leaders, including former CM Digyijaya Singh, attended the event, whose highlight was the amiable exchange between him and Nath about the resentment. brewing in the party over ticket distribution. Later, in a series of posts on X, Singh defended of posts of A, singn defended the ticket distribution process as impartial and promised organisational posts to aspi-rants whom the party had denied tickets. According to the manifesto, a Congress government would

a Congress government would reconstitute the state's NITI Aayog and Statistical Aayog and Statistical Commission to prepare a five-year plan for the state. The par-ty, if it comes to power, would suggest to the Centre that the

A new feature is the focus on landless agriculture work-ers, or as the manifesto has termed them, "fasal rakshak", or protector of crops, with the promise of the government providing them bicycles, agri-cultural tools, and their mini-mum wages out of any com-pensation to the landholder for crop damage. Besides, the Congress has pledged to con-tinue its earlier scheme of waiv-ing farm loans of up to 22 lakh. On the jobs front, the party promised to fill 200,000 gov-

Other highlights of the Congress's "guarantees" are conducting a socio-economic caste Census, increasing other backward class (OBC) reservation from 14 per cent to 27 per cent in the state, a \$25 lakh health insurance and \$10 lakh health insurance and ₹10 lakh neatin insurance and 40 last accident insurance for each family, ₹1,500 monthly allowance for women, cooking gas cylinders at ₹500 each, free electricity up to 100 units and 50 per cent waiver in tariff up to 200 units, doubling social welfare pension from ₹600, free school education and ₹1,500 to school education and \$1,500 to \$3,000 allowance for two years to the landless unemployed educated youth.

With more than 250 global and domestic exhibitors, the seventh edition is expected to draw more than 100,000 visitors this year, he said. There will also be over 5,000 CXO-level delegates and more than 350 speakers.

Imported food item for re-export doesn't need clearance: FSSAI

The Custom authority does not need to send an imported food item for clearance to the Food Safety and Standards Authority of India (FSSAI) if it is meant for re-export or production of value-added items, which are
