We are also in the process of filing the aforesaid Unaudited Financial Results in XBRL. Format within the stipulated time.

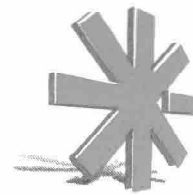

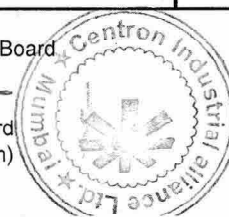

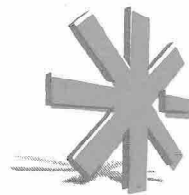

1. The above un-audited Financial Results of the company for the quarter and nine month ended 31st December 2018, were reviewed by the Audit Committee and have been taken on record and adopted approved by the Board of Directors in their Meetings held on 14.02.2019.
2. The results have been prepared in accordance with Indian Accounting Standards ("IND AS") prescribed under Section 133 of the Companies Act. 2013 read with the relevant rules there under and in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015.
3. Since the Company does not have business in more than one segment. Segment wise reporting on Revenue Results and Capital Employed is not applicable.
4. Adoption of Ind AS 155 – Revenue from Contracts with Customers : On April, 2018, the company adopted Ind AS 155, " Revenue from Contracts with Customers" using the cumulative catch – up transition method applied to contracts that were not completed as of April 1, 2018. Accordingly, the comparatives have not been retrospectively adjusted. The adoption of Ind AS 115 did not have any material impact on the standalone results for the Nine months ended 31st December, 2018.
5. Previous Quarters figures have been regrouped/ reclassified wherever necessary.

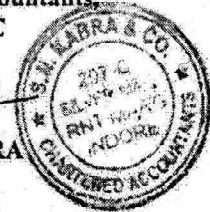
