Sub: Postponement of Board Meeting scheduled on March 16, 2024 to March 19, 2024.

महोदय / महोदया.

With reference to our earlier intimation dated March 5, 2024, this is to inform that the meeting of the Board of Directors of REC Limited, which was earlier scheduled to be held on **Saturday**, **March 16**, 2024 has been postponed due to unavoidable circumstances and will now be held on **Tuesday**, **March 19**, 2024.

As earlier informed, the proposal related to declaration of 3<sup>rd</sup> Interim Dividend, if any, for the financial year 2023-24, will *inter-alia* be considered at the Board meeting to be held on March 19, 2024.

Further, pursuant to Regulation 42 of SEBI (LODR) Regulations 2015, the Company has fixed **Thursday**, **March 28**, **2024** as 'Record Date' for the purpose of ascertaining the eligibility of the shareholders for payment of said 3<sup>rd</sup> Interim dividend, if declared by the Board of Directors.

Further, as per Company's "Code of conduct for regulating, monitoring & reporting of trading by designated persons & their immediate relatives and for fair disclosure" the trading window which was closed since March 6, 2024 to March 18, 2024, will now remain closed till March 21, 2024 for trading in REC's equity shares and listed debt securities (tax free bonds etc.) and the trading window will open with effect from March 22, 2024. During the said closure period, all designated persons and their immediate relatives are advised not to deal in REC's equity shares / securities.
