Dear Sir,

We refer to letter dated 30<sup>th</sup> December, 2020, regarding our appointment as statutory auditors of your company for a period of 5 years.

However, we would like to bring out the fact that our audit fees since we took up the audit assignment has remained the same. Further, the operations of the company completely stopped over the past couple of years affecting the liquidity of the Company which in turn has resulted in significant delays in the payment of our fees which has caused financial hardships to our firm. Moreover, over the past 4 years there have been significant increase in compliances and therefore our costs to ensure compliance. Therefore, in view of the the inadequate audit remuneration in exchange for our services considering the volume of work in terms of the various compliances required under the numerous laws applicable to the company, we are unable justify the fees to meet our costs and accordingly to continue as the Statutory Auditors of the Company for the entire duration of our appointment. We would like to devote our resources in a more cost effective manner.



We would like to place on record our appreciation for the courtesies and assistance extended to us during our tenure as auditors of your Company.

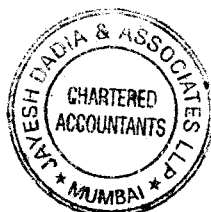
We request you to treat this letter as our resignation from the post Statutory Auditor of the company.
