Sub: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the Company has received an Order dated April 25, 2024 at 3:45 p.m. from Deputy Commissioner, State Tax, Jaipur alleging contravention under Section 73, Section 50 and Section 20 of Central Goods and Service Tax Act/Rajasthan Goods and Service Tax Act. The Order stipulates tax liability amounting to Rs 4,13,742, Interest of Rs 4,09,605 and a penalty of Rs 41,374 aggregating to a demand of Rs 8,64,721. The said demand pertains to GST Audit conducted by Rajasthan state GST Department for the period 2018 - 2019.

Based on our assessment, we believe that the aforementioned demand is not maintainable, and the Company is in the process of preferring an appeal against the said Order. The said Order has no material impact on the financials, operations or other activities of the Company.

The detailed disclosure with respect to the Order as required under the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as 'Annexure – I'.
