The above results for the year ended on March 31, 2019 were reviewed by the audit committee and approved at the meeting of the Board of Directors of the company held on May 21, 2019. This statutory auditors of the Company have carried out the audit of the above results. 2 The above results has been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS), prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable. 3 According to requirement of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the revenue from operations for the year ended March 31, 2018 are inclusive of excise duty for the period April 1, 2017 to June 30, 2017. Goods and Service Tax ("GST") has been implemented with effect from July 1, 2017 which replaces excise duty and other taxes. As per Ind AS 115, the revenue for the year ended March 31, 2018 are accordingly not comparable to that extent with other published periods. 4 The Company is primarily engagend in the Business of PVC Pipes which constitute, a single reportable Segment in accordance with Ind AS 108 - " Segment Reporting" 5 Ind AS 115 Revenue from Contracts with Customers, mandatory for reporting periods beginning on or after April 1, 2018, replaces existing revenue recognition requirements. Under Modified retrospective approach there were no adjustments required to the retained earnings at April 1, 2018. Also, the application of Ind AS 115 did not have any significant impact on recognition and measurement of revenue and related items in the financial results. 6 The figures for the Previous period have been re-grouped / re-classified to confirm to the figures of the current period. The figures for the quarter ended March 31, 2019 and March 31, 2018 are the balancing figures between audited results for the full financial year and the published unaudited year to the figures upto the end of Third quarter of the relevent financial year, which were subjected to limited review. 7 Exceptional Items - (gain)/loss: (Rs. in Lakhs)
