

अयोध्येत २१ लाख दिवे लावून विश्वविक्रम करण्याची तयारी दिवा आणि शरयूचे पाणी प्रसाद म्हणून पाठवणार

अयोध्या, दि. ११ (वृत्तसंस्था) : अयोध्येचा दीपोत्सन दिव्य आणि भव्य करण्यासाठी जय्यत तयारी करणाऱ्या पर्यटन विभाग आणि अयोध्या जिल्हा प्रशासनाने यावेळी २१ लाख दिवे लावून विश्वविक्रम करण्याची तयारी केली आहे. यासोबतच लोकांना घरी बसून दिवाळी सणाचा भाग बनण्याची संधीही देण्यात आली आहे.
