Please note that the Capital Raising Committee of the Board of Directors of the Company ("**Committee**") approved on January 15, 2024, the allotment of 33,23,262 Equity Shares of face value ₹5 each to eligible qualified institutional buyers at the issue price of ₹662 per Equity Share (including a premium of ₹657 per Equity Share and reflecting a discount of ₹34.70 (i.e. 4.98%) on the floor price of ₹696.70 per Equity Share, pursuant to the Issue in accordance with provisions of SEBI ICDR Regulations.

The Issue opened on January 10, 2024, and closed on January 15, 2024 and the same was intimated to you through our intimations dated January 10, 2024 and January 15, 2024, respectively.
