police commissioner will remain present before the court on Friday. On the other hand, AMC counsel GHVirk highlighted before the court that a deputy municipal commissioner of AMC was attacked on Thursday by cattle owners and is now in the hospital.

Justice Shastri acknowledged that he knew about the incident and that is why the court is calling for the municipal commissioner's presence before the court.

Two arrested for obstructing **AMC officials** from removing stray cattle

Ahmedabad: Two persons were arrested on Wednesday night for allegedly obstructing Ahmedabad Municipal Corporation (AMC) officials from removing stray cattle from the roads in Nikol.

According to the FIR, around 8.45 pm on Wedneday, when the drive to remove stray cattle from the road was in progress, Desai came in a bike and started steering the cows present on the road with a wooden stick. He also came in front of the AMC vehicle, hurled abuses, quarrelled with civic officials and chased the cows away, the FIR added. When contacted, Patel said

that unknown men threw stones at the driver of the AMC vehicle but missed.

This is the third FIR lodged since September at Nikol police station on the basis of a compliant filed by the AMC alleging obstruction of duty when civic officials were removing stray cattle. The other FIRs were lodged on September 5 and 29. ENS

The accused has been identified as Raj Desai (22), a resident of Bapunagar, and Lalabhai Rabari, a resident of Nikol. They have been booked under sections 186 (obstructing public servant in discharge of public functions), 294 (b) (obscene acts and songs) and 114 (abettor present when the offence is committed) of the Indian Penal Code. The FIR was lodged on the basis of a police complaint filed by Ashish Patel, a sanitary inschool booked for branding 12 students with hot steel spoon Himmatnagar: The administrator

of an unregistered residential school in Sabarkantha was booked Thursday for allegedly branding at least 12 minor students with a hot steel spoon as punishment for not waking up early in the morning. A case of assault and other offences under the IPC and Juvenile Justice Act was lodged against Nachiketa Vidya Sansthan administrator Ranjit Solanki at Kheroj police station on the basis of a complaint filed by Ramabhai Taral, the father of a 10year-old student. "It is alleged that Solanki had

branded the complainant's son and 11 other students with a hot steel spoon nearly two months ago. He is yet to be arrested," Deputy Superintendent of Police Smit Gohil said. Solanki, a resident of Poshina taluka, is the administrator of Nachiketa Vidhya Sansthan at Kheroj village in Khedbrahma taluka.

A parallel investigation by the office of the district primary education officer revealed it is not a school but an unregistered gurukul with a hostel facility being run by a trust to teach Upanishads, Ramayana and Vedas to students, the police said. As per Taral's complaint, Solanki had branded his minor son and 11 other students for not waking up early in the morning.

He has claimed the trust convinced local tribals that Nachiketa Vidya Sansthan is a regular school with hostel facility. **PTI**
