The state Assembly on Tuesday passed the vote on account of Rs 1.45 lakh crore for coming four months. The main budget will be presented in July. "Normally, debate on vote on account does not take place but a few members participated in the discussion," Speaker Narendra Singh Tomar said.

When Congress MLAs asked state government about the expenditures

on establishment and amount of loan, finance minister Jagdish Devda said, "Answer of the question will be given in July."

Devda said state government would try to incorporate suggestions and recommendations of members in the main budget, which would be tabled in July. He added that total budget for the financial year 2024-25 was around Rs 3.48 lakh crore.

The state's gross domestic product (GDP) has increased to Rs 15.13 lakh crore. It was Rs 13.87 lakh crore earlier. Leader of

Opposition Umang Singh demanded figure of total expenditure on the establishment and the amount which will allocated to repay loan. Finance minister said data would be available in the main budget.

Congress MLA Omkar Singh Markam attacked IAS officials and asked the House to send them in field to know the problems of common people. "Whenever we ask them for some work, they start speaking in English so that we stop asking questions," Markam added.
