### Notes

1. These results reviewed by the Audit Committee were taken on record by the Board of Directors at their meeting held on 25th May 2018.
2. The Company adopted Ind AS from 1st April 2017 and accordingly the financial results are prepared in compliance with Ind AS pursuant to the Notification of Ministry of Corporate affairs (MCA) dated 16th February, 2015.
3. The figures of the Quarter Ended 31st March are the balancing figures between the audited figures in respect of the full financial year and published year to date figures up to the third quarter of the relevant financial year.
4. The Company has only one reportable segment of business i.e. Textile.
5. Reconciliation of the Standalone financial results reported under previous Indian Generally Accepted Accounting Principles (IGAAP) to Total Comprehensive Income in accordance with Ind AS is summarised below.

6. In accordance with the requirements of IND AS, revenue from operation for the period July 1<sup>st</sup> 2017 to March 31<sup>st</sup> 2018 is net of Goods and Service Tax (GST). However revenue from operation for periods upto June 2017 is inclusive of excise duty. In view of the aforesaid change, revenue from operation for the current period ended on March 31<sup>st</sup> 2018 is not comparable to previous period.
7. The Term loans of the company have been restructured by the banks during the year. The company has accounted for the various terms and conditions of the sanction. The implementation of package is under process.
8. 11% Cumulative Redeemable Preference Shares have been classified as Debt and have been recorded at fair value at the time of initial recognition. For Subsequent measurement, Preference share have been valued based on amortized cost as per Ind AS 109.
9. The figures of the previous period / year have been re-grouped /re-arranged and / or recast wherever found necessary.




