#### Scrutiniser's Report (Pursuant to Section 110 of the Companies Act, 2013 and Rule 22 of the Companies, (Management and Administration) Rules, 2014, as amended)

The Managing Director, Force Motors Limited, (CIN: L34102PN1958PLC011172) Mumbai - Pune Road, Akurdi, Pune – 411 035.

#### Dear Sir,

- I, Sanjay Athavale, a Chartered Accountant in practice, have been appointed by the Board of Directors of Force Motors Limited (the 'Company') as a scrutiniser for the purpose of scrutinising the postal ballot forms and e-voting and ascertaining the requisite majority on voting carried out as per the provisions of Section 110 of the Companies Act, 2013, read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014, on the resolutions contained in the postal ballot notice dated 13<sup>th</sup> February, 2019 ( the 'Resolutions').
- 2. The notice dated 13<sup>th</sup> February, 2019 seeking approval of members of the Company along with statement setting out material facts under Section 102(1) of the Companies Act, 2013 and under the Regulation 36(3) of the SEBI (Listing Obligations and Directors Requirements), 2015; was sent to the members in respect of the Resolutions to be passed, through postal ballot. The Company had also provided remote e-voting facility to the members to vote on the resolutions through the electronic voting platform provided by National Securities Depository Limited ('NSDL').
- 3. My responsibility as a Scrutiniser for the postal ballot forms and remote e-voting is restricted to make a Scrutiniser's report of the votes cast in "favour" or "against" the resolutions and "invalid" and "abstained" votes, based on the postal ballot forms received and the reports generated from the e-voting platform provided by NSDL.
- 4. Further to the above, I submit my report as under:
  - The Company has dispatched postal ballot notice and ballot form along with postage prepaid business reply envelope to its members whose names appeared in the register of members / list of beneficial holders as on Friday, 15<sup>th</sup> February, 2019 (End of Day), through courier or through speed post to the members who have not registered their email IDs.
  - II. The Company has dispatched postal ballot notice and ballot form to its members whose names appeared in the register of members/list of beneficial holders as on Friday, 15<sup>th</sup> February, 2019 (End of Day) through email at their registered email ID.
  - III. The remote e-voting period remained open from Thursday, 28th February, 2019 (9:00 A.M.) to Friday, 29th March, 2019 (5:00 P.M.).
  - IV. The members whose names appeared in the register of members as on the "cut-off date i.e. Friday, 15th February, 2019, (End of Day) were entitled to vote on the resolutions as set out in the Postal Ballot Notice of the Company.
  - V. The remote e-voting facility was unblocked on Friday, 29<sup>th</sup> March 2019 immediately after the completion of voting hours in the presence of 2 witnesses, Mr. Subhash Jadhav and Mr. Dnyaneshwar Ghadge, who are not in the employment of the Company.

- VI. The postal ballot forms were kept under my safe custody in sealed and tamper proof envelopes before commencing the scrutiny of such postal ballot forms.
- VII. All postal ballot forms received up to 5.00 p.m. on Friday, 29<sup>th</sup> March, 2019, being the last date fixed by the Company for the receipt of the forms, were considered for my scrutiny. Envelopes received after Friday, 29<sup>th</sup> March, 2019 were not considered. All votes cast on NSDL e-voting platform upto 5.00 p.m. on Friday, 29<sup>th</sup> March, 2019 were considered for my scrutiny.
- VIII. The postal ballot forms which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- IX. Particulars of all the postal ballot forms received from the members by Friday, 29<sup>th</sup> March, 2019, are manually entered in the register for the purpose.
- X. A total of 45 envelopes containing postal ballot forms were returned undelivered. These envelopes are not opened and are kept separately.
- XI. The details containing, inter alia, votes cast in "favour "or "against" on the resolutions that were put to vote, and whose votes became invalid and number of votes abstained from voting, for remote e-voting report is generated from the e-voting website of NSDL - i.e. https://www.evoting.nsdl.com/ and the details of postal ballot forms is manually entered by me, Thereafter considering votes through remote e-voting and votes cast through postal ballot forms, the combined result of the voting is given below.


