- 1. An Explanatory Statement pursuant to Section 102(1) of the Companies Act, 2013, setting out material facts and reasons for the Special Business is annexed hereto and forms part of this Postal Ballot Notice.
- 2. The Postal Ballot is to being conducted as per provisions of Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013, Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and MCA Circulars issued from time to time. The circular dated 25.09.2023 conveyed the decision of MCA to allow companies to transact items by means of a postal ballot by electronic mode (e-voting) up-to 30.09.2024.
- 3. In compliance with the aforesaid MCA Circulars, the Postal Ballot Notice is being sent only in the electronic form to all shareholders of the Company who have registered their email ids with the Company or Depository as on Friday, 17th May 2024 (cut-off date) and physical copy of Postal Ballot Notice will not be sent to the shareholders. A person who is not a member as on the Cut-off date should treat this Postal Ballot Notice for information purpose only.
- 4. The Company has engaged Central Depository Services Ltd (CDSL) as e-voting agency for facilitating e-voting to enable the Members to cast their votes electronically.
- 5. The remote e-Voting period commences on Wednesday, 22nd May 2024, 9AM and ends on Thursday, 20th June 2024, 5 PM. During this period, members of the Company holding shares as on the cut-off date may cast their vote electronically. The remote e-Voting module shall be disabled thereafter. Once the vote on the resolution is cast by a member, the same will not be allowed to be changed subsequently. The voting rights of the Members shall be in proportion to their shareholding in the paid-up equity share capital of the Company as on the Cut-Off Date i.e 17th May 2024.
- 6. The date of resolution will be 20thJune 2024. Results of e-voting will be submitted to the stock exchanges within two working days from the date of end of e-voting. A copy of the same will be placed in the website of the Company.
- 7. The Board of Directors has appointed Shri Sriram Parthasarathy, a Practising Company Secretary and Partner of M/s SPNP & Associates, Practicing Company Secretaries, Chennai, as Scrutinizer for conducting the Postal Ballot and e-voting process in a fair and transparent manner.

 - (i) The voting period begins on Wednesday, the 22ndMay 2024, 9AM and ends on Thursday, 20th June 2024, 5 PM.
