Sir,

I, Kapil Dev Vashisth, Practicing Company Secretaries, was appointed Scrutinizer by the Board of Directors of M/s Nimbus Projects Limited pursuant to Section 110 of the Companies Act, 2013(herein after "Act") read with Rules 20 and 22 of The Companies (Management and Administration) Rule, 2014 (as amended) to scrutinize voting by postal ballot and by remote 'e-voting' in respect of the resolution proposed to pass through postal ballot process.

The management of the Company is responsible to ensure the compliance with the requirements of the Acts read with Rules made thereunder and SEBI (Listing Obligations & Disclosure Requirement) Regulations, 2015 relating to postal ballot process. Our responsibility as scrutinizer is restricted to reporting of votes cast by the members on the resolution contained postal ballot notice dated 28th December, 2018.

The notice of postal ballot dated 28<sup>th</sup> December 2018 was dispatched to the equity shareholders by prescribed mode and newspaper advertisement in this regard was published on 09<sup>th</sup> January, 2019 pursuant to rule 22(3) of The Companies (Management and Administration) Rule 2014. The National Securities Depository Limited (NSDL) has provided the remote 'e- Voting' platform to the members. The remote e-voting commenced on NSDL e-Voting platform on Wednesday, 09<sup>th</sup> January, 2019 (09.00 a.m.) and ended on Thursday,

 $07^{th}$  February 2019 (05.00 p.m.). The voting by physical postal ballot ended on 05.00 p.m. on Thursday,  $07^{th}$  February 2019.

The equity shareholders holding shares on Saturday, 29th December 2018, the "Cut Off" date, were entitled to vote on resolution stated in the notice of postal ballot.

The postal ballots were kept under the safe custody in the sealed tamper proof Ballot Box before commencement of scrutiny of postal ballot forms. In the due course of scrutiny physical postal ballots were opened and the physical ballots received were reconciled with records maintained by the Company/ Registrar & Transfer Agent (R & TA) and Authorization / Power of Attorney etc. lodged with the Company.

The e- voting facility was disabled by NSDL after completion of e- Voting period on Thursday, 07th February 2019 (05.00 p.m.). The remote e-votes were unblocked on 08th February 2019 in presence of Mr. Chandra Kishore Mittal and Ms. Apurva Gaur who were not in employment of the Company. I have scrutinized the e- voting pattern downloaded from NSDL e- Voting system.

The votes were also scrutinized for the purpose of eliminating the duplicate voting i.e e-Voting as well as by physical ballots. The detail of invalid votes is also mentioned in this report. Further, I did not find any defaced or mutilated postal ballot form.

Now, I submit the result of physical ballot paper and remote e-voting in respect of the resolution contained in the notice of postal ballot:
