Subject: BSE Query dated 06.11.2023 & 23.01.2024 reply regarding non maintenance of Structured Digital Database (SDD)

Dear Sir/Madam,

We have received a notice on the web portal of BSE i.e. the Listing Centre under the newly created head "**Communication Module**" and also through an email dated 06.11.2023 & 23.01.2024 from "noreply@bseindia.com" regarding non-maintenance of Structured Digital Database (SDD).

As enquired by you, on the stock reach page on the Exchange website, which continues to display the non-compliance status regarding non-maintenance of Structured Digital Database (SDD) by the Company as per the provisions of Regulation 3(5) and/or Regulation 3(6) of SEBI (Prohibition of Insider Trading) Regulations, 2015.

In this regard, please note that, the Company was served Notice for SDD non-compliance by BSE Listing center on 05.09.2023 which was suitably addressed by the Company via reply dated 11.10.2023 and accordingly the matter was resolved in consultation with BSE Team (*reply attached for your reference*), but, the matter has again been lifted by BSE on same grounds via query dated 06.11.2023 & 23.01.2024.

Therefore, it is again reiterated that, the matter regarding SDD software installation was discussed with the COC, wherein the COC in view of the Resolution Plan approved by them for reviving the Company which is already submitted before Adjudicating Authority for approval and is under adjudication. Also, the members highlighted and emphasized about no business operations in the Company resulting in lack of funds, and there being only one employee besides the CS. Further, as the Resolution Plan is on the verge of getting approval

from Hon'ble NCLT in the next date of hearing (i.e. on 05.03.2024) the members recommended to not to install the SDD Software at this juncture and to let the new management post NCLT approval to install the required SDD Software and take other corrective actions as and when required

In addition to the aforesaid, please note the company is under CIRP and there being no business operation at present there is no revenue generation and only the cost necessary for running the CIRP, including cost to protect and preserve the assets, etc are being incurred. The Resolution Applicant upon approval of the Resolution Plan by Hon'ble NCLT will takeover the business of the Company and will recommence the revenue generating operations. Therefore, the Resolution Applicant will only be in the position to maintain the required database and comply with the provisions of the said Regulations.

In view of the above said facts your good office is required to please resolve the issue w.r.t. Non-compliance of SDD Software and to remove the name of the Company from the list of Companies that are SDD Non-Compliant.

You are requested to take the above-mentioned information on record and oblige.

The SDD Compliance Certificate was to be submitted from a Practicing Company Secretary ("PCS") along with their comments. The PCS **M/s Seema Sharma & Associates** provided clarification and comment in this regard in their SDD Compliance Certificate dated 12.07.2023 (*attached for your reference*).

Further another Notice bearing no. LIST/COMP/KK/649/2023-24 dated 05.09.2023 was served in this regard. Please note, at the instant Company namely M/s Vikas WSP Limited is under Corporate Insolvency Resolution Process ("CIRP") pursuant to Hon'ble NCLT, Chandigarh Bench order dated 02.02.2022 wherein the tribunal appointed Mr. Darshan Singh Anand (IP Registration No. IBBI/IPA-002/IP-N00326/2017-2018/10931) as the Interim Resolution professional ("IRP") and subsequently as the Resolution Professional ("RP") by the members of CoC in their 2nd CoC Meeting held on 17.03.2022 and taken on record by Hon'ble NCLT on 16.11.2022.

Further, as per the provisions of the Insolvency and Bankruptcy Code ("IBC"), 2016 during the CIRP period the affairs of the business and assets of the Company are managed by the RP, and the powers of the board of directors stand suspended and are vested in the RP.

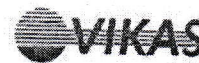

Resolution Plan was submitted with Hon'ble NCLT on 31.10.2022 as per the provisions laid in Section 30(6) of the IBC, 2016 and the same is being adjudicated.

Further, we would like to clarify that, the access to the material information of the Company is only available with the Compliance Officer, Company Secretary and the designated officials of the Secretarial team. The Company has all the internal financial and operational controls to the extent possible which are subject to periodical management, secretarial and internal audit.

The Financial records are maintained on Tally Software, operated and managed by the office of the RP and is shared with the Internal Auditor and Statutory Auditor for the limited purpose of Audit as and when required.

In view of the aforesaid, we would like to bring to your information that, at present the Company is not in a position to install the SDD Software. Further, there are only two employees working in the Company including a Company Secretary and all records required to be maintained, are being maintained to the best possible extent.

We would like to reappraise that, IBC, 2016 has an overriding effect and accordingly the Board of Directors stand suspended and the powers are vested in the RP to be exercised in consultation with the CoC. Thus, the board of directors cannot comment on installation of the SDD Software, management of the affairs of the business and assets of the Company. As the power of the board is vested in the RP, namely Mr. Darshan Singh Anand as per the provisions of IBC, 2016 accordingly the comments of the RP regarding non-installing of the SDD Software are provided below:
