IN BRIEF

FSB proposes Rana Ashutosh Kumar Singh as SBI MD

Financial Services Institutions Bureau (FSB), the regulator of non-banking financial companies (NBFCs) and financial institutions, on Wednesday recommended Rana Ashutosh Kumar Singh (pictured) for the post of managing director at State Bank of India (SBI). Singh is currently serving as deputy managing director at SBI. Following the result of the selection process, the FSB in a statement said the Bureau interviewed 16 candidates on April 23 and 24. "Keeping in view their performance in the interview, their overall experience and the extant parameters, the Bureau recommends Rana Ashutosh Kumar Singh for the position of MD in SBI," it said.

Pharma exports rose 10% to \$27.9 billion in FY24

The country's drugs and pharmaceutical exports increased 9.67 per cent year-on-year to \$27.9 billion in 2023-24, even as the total exports dipped by 9 per cent in the last financial year. According to the commerce ministry data, pharma exports in March grew by 12.73 per cent to \$2.8 billion. In 2023-24, the exports stood at \$25.4 billion. The top five export markets, for the sector during the last fiscal, are the US, the UK, the Netherlands, the United Kingdom, South Africa and Brazil. The US accounts for over 31 per cent of India's total pharma exports, followed by the UK and Netherlands (about 3 per cent each).

RBI's compiled master direction on ARCs effective from April 24

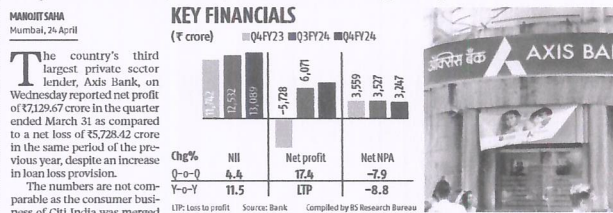
The Reserve Bank of India (RBI) on Wednesday released a master direction for asset reconstruction companies (ARCs), saying the guidelines will be effective from April 24, 2024. ARCs are expected to have a minimum capital requirement of ₹300 crore, compared to ₹100 crore as on October 31, 2022. Extra ARCs will be provided a glide path to achieve the minimum required Net Owned Fund (NOF) of ₹300 crore as on March 31, 2025. ARCs must have a minimum capital of ₹700 crore by March 31. ARCs with a minimum NOF of ₹1,000 crore can act as resolution applicants.

RBI deputy gov Rabi Sankar gets 1-year extension

The government has extended the term of RBI Deputy Governor Rabi Sankar for a period of one year, the central bank said in a statement. "The central Government has re-appointed Shri T. Rabi Sankar as Deputy Governor, Reserve Bank of India, for a period of one year with effect from May 01, 2024, or until further orders, whichever is earlier," it said. Sankar was appointed as the RBI Deputy Governor in May 2021 for a period of three years. He joined the RBI in 1990 and worked in various positions at the central bank.

Axis Bank Q4 profit rises 9%

NII grew 11% to ₹13,089 cr, while fee income grew by 23% to ₹5,637 cr



The country's third largest private sector lender, Axis Bank, on Wednesday reported net profit of ₹2,046 crore in the quarter ended March 31 as compared to a net loss of ₹5,728.42 crore in the same period of the previous year, despite an increase in loan loss provision. The numbers are not comparable as the consumer business of Citl India was merged with Axis in the fourth quarter of FY23. Net interest income (NII) grew 11 per cent year-on-year (Yo-Y) to ₹13,089 crore while fee income grew by 23 per cent to ₹5,637 crore. The trading income gain for the quarter stood at ₹1,021 crore.

ICICI Bank Q4 profit rises 9%

The country's second largest private sector lender, ICICI Bank, on Wednesday reported net profit of ₹2,359 crore in the quarter ended March 31, up 9 per cent from ₹2,164 crore in the same period of the previous year. Net interest income (NII) rose 11 per cent to ₹13,089 crore while fee income grew by 23 per cent to ₹5,637 crore. The trading income gain for the quarter stood at ₹1,021 crore. Net interest margin for the quarter was 4.06 per cent, up 5 bps sequentially. Provision for the quarter was ₹1,883.21 crore as compared to ₹3,057.72 crore mainly due to rise in provision for non-performing assets which went up from ₹270 crore in the Q4 of FY23 to ₹832 crore. Total slippages during the quarter was ₹3,471 crore. Provision coverage ratio was at 79 per cent.

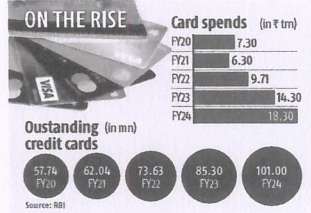
The total deposits grew 13 per cent Yo-Y while the current and savings account deposits were 43 per cent of the total deposits. Advances grew 14 per cent Yo-Y to ₹96,117 crore. The lender's provisions for non-performing assets declined 20 per cent to ₹1,883.21 crore as on 31st December 2023.

AU SFB's profit drops 12% to ₹70 crore in Q4

AU Small Finance Bank reported a 12.69 per cent decline in net profit to ₹70 crore for the quarter ended March 31, compared with ₹80.66 crore in the corresponding quarter of the last year, mainly on the back of a rise in provisions. Sequentially, the profit fell 11.9 per cent. But the numbers are not strictly comparable as Fincare SFB was merged with AU SFB in the Jan-March quarter. Provisions for the quarter ended March surged by 224 per cent to ₹54,31.48 crore, compared to ₹40.8 crore in FY23. ANJALI KUMARI

FY24 credit card spends rose 27%

Increased to ₹18.26 trillion from nearly ₹14 trillion a year ago



Credit card spends surged 27 per cent year-on-year (Yo-Y) to ₹18.26 trillion in financial year close and first quarter of 2023-24 (FY24) from nearly ₹14 trillion in the year-ago period, according to the latest data released by the Reserve Bank of India (RBI). In March 2024, credit card spends rose nearly 10.07 per cent to ₹1.64 trillion from ₹1.49 trillion in February. This is on account of the financial year close and festive sales during March.

"The festive season and the fact that March is the year-end are likely to have driven transactions during the month on a sequential basis. Credit card spend will continue to grow although it is likely to moderate owing to a higher base and regulatory scrutiny," said Sarabh Bhalekar, associate director, CareEdge Ratings.

Of the total ₹1.64 trillion credit card transactions, the total number of credit cards issued by banks in India has increased to 101 million in March 2024. It was 100.60 million at the end of February 2024. HDFC Bank is the leader in credit card issuances with the lender's cards in circulation standing at 20.59 million. Other major players include SBI card with 18.89 million cards, ICICI Bank (16.95 million) and Axis Bank with 14.21 million cards.
